

The successful candidate will be primarily responsible for providing clinical Social Work services to children, adolescents, and their families on the children's inpatient medical and surgical specialty services. There may be outpatient referrals from a variety of children's services as needed. Social Workers are also actively involved in research, academic pursuit, and the sharing of knowledge in the study of psychosocial aspects of illness and health care delivery.
