## POLICY

The Children's Health Foundation is a critical partner to the Children's Hospital at London Health Sciences Centre (LHSC) and manages the receipt, coordination, and facilitation of all donations to the CH, LHSC.

Toys and child-appropriate gift items are always needed at Children's Hospital at (LHSC) throughout the year. The Children's Hospital at LHSC is very appreciative of the generosity of individuals and organizations within our local community and surrounding areas that help us by providing much needed items for patients and families.

## PROCEDURE

## **Donation Guidelines**

- i. Due to infection control guidelines, allergies, compromised immune systems, safety precautions and limited space, all donations must be new, in original packaging and be recently purchased.
- **ii.** Please do not wrap your donation(s).
- iii. All items are assessed prior to distribution for the safety of our infants, children and youth.
- 1. All offers or requests to donate gifts in kind\* to the Children's Hospital at LHSC must be directed to the Children's Health Foundation at 345 Westminster Avenue, London, ON.
- 2. All requests for on-site donation drop offs and/or gift distribution to Children's Hospital at LHSC must be directed to the Children's Health Foundation at 345 Westminster Avenue, London, ON.
- **3.** For requests made by donors to drop off gifts in kind at the Children's Hospital at LHSC location, the Children's Health Foundation will initiate the approval and coordination process. If approved, the drop off event will be led by Children's Health Foundation staff.
- 4. Children's Hospital leadership must approve all Children's Health Foundation events to be held on-site at the Children's Hospital at LHSC.
- 5. Donor tours for gift distribution directly to patients and families in the Children's Hospital at LHSC are not permitted.
